designated shelters. The picture on the top right shows the rebuilding of a house from a family of 12. During the storm their house was completely destroyed as seen in this picture. They really had a tough time and it was a blessing to help them get back on their feet.

The place we meet was also affected by the storm. The roof was mostly taken away. Our apartment is



newly constructed and we are on the second story so we stayed there. The biggest problem was having to mop the floor for five hours straight. The blowing rain was coming in all the windows and flooding the floor. Praise the Lord it is all over!

### LGBT:

In my last letter I wrote, "Sadly the US Embassy raised the LGBT flag here in Belize. Please pray as their agenda is being pushed on this country." Now there is even more reason to pray. Here is an excerpt from a recent email I received, "The Chief Justice ruled in favor of Orozco and UNIBAM in the sodomy lawsuit on Aug. 10th. Analyzing the ruling with Senior Counsel attorneys, please understand that the Chief Justice gave them a "blank check green light" on all LGBT rights! You mean SAME SEX MARRIAGE? ALL LGBT RIGHTS!!" Sadly, the Government of Belize is not going to appeal this decision. This is just another example of where one judge rules against the laws of God and the will of the people. The vast majority of Belizeians do not want this. Please join us in prayer as on this coming Tuesday August 23rd we will be gathering at the National Assembly Building in the Capital of Belize to pray and stand against this injustice.
